SUBJECT:	Interpretation of Standing Order 5

1. Recommendations

1.1 That members determine their interpretation of the words 'Leading Group' as set out in Standing Order number 5.

2. Background

2.1 Standing Order number 5 states:

Leader of Council/Opposition Spokesperson

At the Annual Meeting the selection of the Leader of the Council shall be announced by the Leading Group on the Town Council and the Opposition Spokesperson(s) by the minority group(s) provided that any changes in those nominations may be made at any time during the Civic Year at a meeting of the Town Council.

- 2.2 Agenda item 4 for the meeting of the Annual Town Council Meeting indicates that there will be an announcement of who is to be the Council Leader by the 'Leading Group'.
- 2.3 In 2023 at last year's Annual Town Council meeting the Independents for Newark and District held a numerical majority of the total number of Councillors on Newark Town Council (10 out of 18). As such they were quite clearly the 'Leading Group'.
- 2.4 Since the last Annual Town Council Meeting, political changes in the make up of the Council are such that the Independents for Newark and District (IFN&D) no longer hold a numerical majority of the total number of Councillors (now 8 out of 18). Despite that they remain the largest group in terms of numbers albeit without an overall majority.
- 2.5 Standing Orders are silent as to interpretation of 'Leading Group'. In recent history where the Council has had no overall majority from a single group or political party there has been no Leader appointed.
- 2.6 If members are content that 'Leading Group' is the group with the most numbers but not a numerical majority then Agenda Item 4 can proceed with the IFN&D confirming their appointed Leader of the Council.
- 2.7 During the course of the last Civic Year the Council has devolved certain powers to the role of Leader including 'Towns Fund Board' representative, recruitment activities and certain procurement decisions. It is expected that these appointments continue after the Annual Town Council Meeting.
- 2.8 There has been a more general expectation that there would continue to be an appointed Leader of the Council following the Annual Town Council meeting.

- 2.9 If members are unable to resolve to accept that Standing Order 5 allows for the Leading Group to be deemed to be the IFN&D as the group with most members, the whole question of firstly having a Leader at all and secondly the process for appointment of a Leader would require review and as such a deferral of any appointment would be recommended to allow for Standing Orders to be re-written on the issue of the appointment of a Leader. A general review of Standing Orders is scheduled in the early part of the new Civic Year.
- 2.10 The role of Leader is one that is uncommon amongst Town and Parish Councils. The role has no specified authority or power greater than any other Councillor attached to it. The success of the role is down to the individual undertaking such role. Generally, although not formally documented the role involves the following:
 - To act as a regular liaison with the Town Clerk with a view to then disseminating relevant information in appropriate circumstances to other members of all groups and parties.
 - To provide occasional press quotes that reflect the resolved position of the Council.
 - To provide a report as part of the Agenda for Town Council meetings.
 - To undertake any roles specifically devolved to the Leader.
 - To be an advocate and spokesperson for the Council as a whole (not the group they represent).
 - To help to galvanise the Council in delivering effective governance.
 - To help to co-ordinate Council wide governance activity with the Chairman of relevant Committees, Sub Committees and Working Groups.
 - To be a general sounding board for the Clerk, Senior Officers and other members.
- 2.11 The Clerk has found the role of Leader helpful and useful in the last 12 months. During what has and continues to be a challenging period for local government including Newark Town Council, the often-daily support and input of the Leader has been a valuable resource.

- 2.2 The Council is under no obligation to continue with the same composition of the membership of the Committees and Sub Committees as has been in place in the preceding Civic Year. The current appointments are detailed in Appendix 1.
- 2.3 The Council has in recent years sought to provide that the Planning Committee and Personnel Sub Committee are proportionately represented by each group, with the number of members on each reflective of the overall political / group make-up of the entire Council. There is no legal obligation to do this however the attached Appendix 2 sets out the current proportionate representation numbers and suggested composition that as close as possible meets the proportional representation figures.
- 2.4 Members will be aware that there is an evolving narrative that looks at some significant changes to the Committee structure that will be subject to further analysis, review and potentially a resolution to change the structure and so changes to the appointments made in response to this report may be subject to further change at a later date.

SUBJECT:	GENERAL POWER OF COMPETENCE ('GPC')

1. Recommendations

That the Council resolves to declare that it continues to meet the conditions of eligibility for exercise of the General Power of Competence (created by the Localism Act 2011) and as prescribed by the The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012

2. Background

What is General Power of Competence?

It is a legal provision that gives power to Town and Parish Councils to do anything that an individual can legally do.

When introduced by the Localism Act 2011 it expanded the legal powers already available to Town and Parish Councils.

The ability to use General Power of Competence is subject to the Council meeting certain criteria (see below).

Newark Town Council and GPC

The ability to use GPC by Newark Town Council was first introduced in 2022 following the appointment of the current Town Clerk. The appointment resulted in the Council having a Clerk with a relevant qualification that meets the criteria for use of GPC. Prior to that point Newark Town Council did not meet the criteria to use GPC.

The Criteria

- 1. That the Clerk holds one of the prescribed qualifications.
- 2. That at least two thirds of the members are elected Councillors (if too many Councillors are co-opted Councillors the criteria is not met).

Annual Declaration of Eligibility

The legislation requires that there must be an annual declaration from the Council by resolution at its annual meeting that the criteria continues to be met.
